<i>Park(s) Update</i>	<p><b>Buell Park</b> –Updates provided by Merrill.</p> <p><b>Parking lot</b> is in – black top has been poured and taped off from any traffic at this time.</p> <p><b>Vault Toilet</b> – based upon corresponds is looking at 1<sup>st</sup> or 2<sup>nd</sup> week in August.</p> <p><b>Concrete</b> will be poured all at the same time – after vault toilet installation.</p> <p><b>Tables/Benches</b> is looking like September / October.</p> <p><b>Buoys</b> noted to be \$100.00 more in cost and the board did approve this increase in purchase price at the May meeting. Merrill will check on the status.</p> <p><b>Kiosk Sign</b> – Wildlife panel is ready; they are looking for a picture of May Buell and may be contacting the Bear Lake Museum. Once the panels are sent to Merrill to proof, she will be sending out to the group to review.</p> <p>Currently everything is ordered – we are just waiting on availability.</p> <p><b>Rocks located at Road End</b> – Wolverton noted there are two rows of rocks at the road end; one where cars are parked, the other rocks are closer to the water’s edge. Suggested rocks be moved that are closer to the water to some other location so that children are not injured.</p>	<p><i>Merrill to check with Spicer on status of buoys.</i></p> <p><i>Motion by Wolverton, second by Gauthier to have rocks moved to a different location. Merrill to check with road commission on moving the rocks. All in favor, motion carried</i></p>

	<p><b><i>Township Park</i></b> – Gate has been painted as well as pavilion power washed and painted.
