Merrill to check on order and it should take four (4) weeks to order and install. **Buoys* – these are in and ready to be installed. Cement bases at park. Merrill has someone who volunteered to install. **Light* – Consumers Energy will be hooking up electricity the first week in May. **Shed* – Discussed pea gravel vs repurposed gravel or cement slab. The group decided pea gravel was a good option. **Merrill to check at Pahls for an 8 x 10. **Folding Bench for bathroom* - Gauthier brought pictures of bench at Onekama rest room. Same as the one Merrill had already suggested. **Rain Garden* – A car was doing donuts in the parking lot over the winter and went into the rain garden.
