<i>Park(s) Update</i>	<p><b>Buell Park</b> – Merrill gave update to committee.</p> <p><b>Concrete Beach Access</b> – EGLE has issued a violation. Expected information in the next couple of weeks on what needs to be done.</p> <p><b>Benches</b> – Swidorski is waiting for EGLE determination before installation.</p> <p><b>Grills</b> – noted they are not surrounded by cement for handicap accessibility. Merrill will talk to Spicer regarding cement.</p> <p><b>Kiosk Sign</b> – Two panels are ready and should be installed by the end of next week. These include the Buell Family and Wildlife information.</p> <p><b>Fence</b> – marked out and waiting for installation.</p> <p><b>Buoys</b> – installed, but more weight is needed to hold in place.</p> <p><b>DNR Sign</b> – Swidorski / Spicer to order.</p> <p><b>Cross Walk Markings</b> – These have faded out. Merrill looking at options i.e., cold overlay plastic from PK Contracting with a price of \$1,575.00 for one crosswalk. Decided to go with</p>	

	<p>a 5-gallon bucket of white paint and repaint prior to ordering the pricier option.</p> <p><i>Signs for road</i> – Noted light up sign for crosswalk has a cost of \$1600 – 5,000.</p> <p><i>Cross Walk Signs</i> – Swidorski will be installing.</p> <p><i>Sign for directions to park</i> – Merrill will be talking with Traverse City MDOT office for clarification.</p> <p><i>Shed</i> – ordered. The shed will have pea gravel underneath. The township had a prior donation of \$5,000 from Mrs. Burley. We will use this to purchase the shed, pea gravel and equipment stored in the shed. A plaque will be placed on the shed noting the generous donation.</p> <p>Items needed for the shed:</p> <ul style="list-style-type: none"> <li>• Wheelbarrow – two (2) tires</li> <li>• Rakes x 2</li> <li>• Shovel</li> <li>• Metal Can for Grill Ashes</li> <li>• Pitchfork</li> <li>• Wall Hangers</li> <li>• Broom / Dustpan</li> <li>• Shelf for supplies</li> <li>• Plastic Container to hold Garbage Bags, Toilet Paper.</li> <li>• Numeric lock</li> <li>• Pruner</li> </ul> <p><b><i>Bear Lake Watershed</i></b> – Flowers are blooming and will be doing bench under the big tree in memory of Dick Graham.</p>
