Approved Minutes

July 11, 2023

Meeting called to order at 6 pm.

Merrill welcomed everyone which was followed by the Pledge of Allegiance.

Motion by Merrill, supported by Schweyer, to add to agenda: Three Pines Road, hall shed/area behind pickleball court and email correspondence from Bill LaBelle; all in favor; Motion carried.

NEW BUSINESS

Merrill is looking into the potential abandonment of the Lumley Drain. She will contact the Road Commission to see if they will maintain the culvert if the drain is closed.

Motion by Merrill, supported by Girven, to approve the Large Scale/Commercial Solar ordinance – roll call vote – ayes: Girven, Schweyer, Monk, Merrill, Cross; Motion carried.

Motion by Girven, supported by Cross, to approve the Residential Solar ordinance – roll call vote – ayes: Schweyer, Monk, Merrill, Cross, Girven; Motion carried.

UNFINISHED BUSINESS

The final checks for the Sewer Authority have cleared and it is officially dissolved.

Nuisance violations were discussed. Court proceedings for Golden and Brunais will take place. The Board decided a 90-day deadline for the fire and back-lot clean up on Norconk Rd. Merrill will send a letter.

OTHER BUSINESS

The Board discussed the condition of Three Pines Road which is 6" lower than the driveways on the section at Myers Road end to the curved area. Merrill will talk with the Road Commission about our cost.

The shed behind the pickleball court is in need of clean-up and paint. Merrill will talk with Richard.
