Motion by Monk, supported by Schweyer, to add the two ordinances approved last night at the Planning Commission meeting (see NB) & correspondence from Todd & Mary Zalud; AIF; Motion carried.

Motion by Monk, supported by Schweyer, to approve Supervisor's receipt of the Treasurer's Report; AIF; Motion carried.

Motion by Cross, supported by Girven, to approve paying the monthly bills including remaining routine payroll/invoices, AIF; Motion carried.

#### **NEW BUSINESS**

Motion by Girven, supported by Schweyer, to re-approve the resolution for poverty exemptions for 2022 (the state has removed one sentence on the second page), roll call vote – ayes: Cross, Girven, Schweyer, Monk; AIF; Motion carried.

Motion by Schweyer, supported by Cross, to approve removal of "Section 8007.B-Substitution" from the Zoning Ordinance pertaining to non-conforming use, buildings or structures; AIF; Motion carried.

Motion by Schweyer, supported by Girven, to approve a change to 1004 General Provisions; 6. in Zoning Ordinance changing to "No direct light source, which is not diffused or shaded shall be permitted." AIF; Motion carried.

### UNFINISHED BUSINESS

The Sewer Authority is still waiting for a range of technical questions to be answered before holding a public hearing.

Discussion regarding letters sent last month regarding nuisance violations, i.e. one more letter would be sent stating a 45-day compliance is being requested or legal proceedings will be taken. One of these will not be acted on due to correspondence received about cleanup efforts, the other property is looking better.

Motion by Monk, supported by Schweyer, to approve purchasing the soldier silhouette \$381.60 for the Veteran's Memorial at the cemetery, using funds from the cemetery account within the Manistee County Community Foundation; AIF; Motion carried.
