### **Approved Minutes**

Meeting called to order at 6 p.m.

Motion by Schweyer, supported by Girven, to approve the September board minutes; AIF; Motion carried.

Motion by Monk, supported by Schweyer, to approve Supervisor's receipt of the Treasurer's Report; AIF; Motion carried.

Motion by Girven, supported by Merrill, to approve paying the bills and any other remaining routine payroll/bills for the month; AIF; Motion carried.

### **NEW BUSINESS**

Pleasanton Township Park; Discussed under Guest area. It was noted that the Township does not plow the park.

Transfer station dates 2023: Merrill distributed proposed dates, approved by board.

Discussed contract coming up for negotiation in 2023.

### **UNFINISHED BUSINESS**

Two Lakes Sewer Authority – Girven noted waiting on two items; one from Wade Trim regarding an environmental issue, and an addition to the document noting looking at “what will occur by doing nothing”.

Nuisance violations – Merrill gave report on status of one violation. There are a few more the board decided should all be done at the same time to potentially have reduced attorney fees.

County Recycling - Motion by Merrill, second by Schweyer, to have Pleasanton Township go to the County Recycling Program for a period of two (2) years. Roll call vote: Merrill – Yes, Girven – Yes, Schweyer – Yes, Monk – Yes, Cross - Absent. Motion approved.

#### OTHER BUSINESS

BS&A accounting software AP-Payroll pending Q&A – Amy is working on.

Cemetery – Merrill noted Spicer has placed pink flags at the corner markers. Also noted from Lori/Sexton that there are some lots that are vacant for more than 40 years. We may need to look at in the spring.

#### PUBLIC COMMENT:

Raiff – County Recycling vs Current with Republic services

Jaquish – Noted County Commission position is for two (2) years and will change to four (4) years afterwards. This is a state change. Also, she will remain on the Centra Wellness and Dial A Ride Boards.
